- -NPDES is alive and well. Check to make sure you are in compliance if it affects you.
- -EPA: language on labels may be changing as re-registration of products move the process, worker protection standards will probably be revised late 2013.
- -Government Relations: still have gridlock in DC especially on farm bill, which had attachment for relief for aerial applicators.
- -Communications: for NAAA members there is the e-newsletter with interesting info and updates, the website which has numerous links and info pertinent to aerial application, the magazine with articles on a variety of topics and reports from our executive director, Andrew Moore, and other leaders in our Association.
- -Constitution and By Laws: There is a big push to revise both to come into compliance with the articles of corporations within the Washington DC area. This will be a long term project but should ultimately lead to simplified terminology and less confusion.

We are working on sponsorships again this year and are hoping to get both programs sponsored. If you have any suggestions or ideas, please let us know.



# Chemical Spill Response Training



Smarter Ways To Grow

It's not a matter of if a chemical spill is going to occur, it's just a matter of when! Think about the products we transport on public highways. Even the gasoline or diesel fuel in your vehicle may become spilled in a traffic accident.

#### Did you know?

In 2012 alone, EPA filed 121 enforcement actions in Florida, including a \$125,000 fine for improper disposal of shop chemicals. Do you know the rules?

In 2012, there were over 32,000 spills large enough to require reporting to the federal government. Failure to make the necessary notifications can result in substantial fines. Fuel products require reporting in some situations of only one drop is spilled. Do you know what they are?

EPA's SPCC rule (Spill Prevention, Control, and Countermeasures) rule will affect practically every golf course, grower, and many other applicators. The deadline is May 10th, 2013. Are you prepared?

OSHA requires splil response training for employees responding to an emergency. Responding to a spill utilizing your own personnel and equipment costs a fraction of what an environmental contractor would charge you. After a traffic accident regardless of fault any spilled fuel products or pesticides must be cleaned up! Fire department personnel will insist that the spill be cleaned up properly. Without proof of training, you may be required to hire an environmental contractor.

CPS/AAT is offering chemical spill response training in your area to prepare your employees to respond to an emergency. Topics include: Spill response procedures, decontamination, personal protective equipment, respiratory protection, chemical storage and handling, and more. Registration fee for the course includes a textbook, DOT emergency response handbook, and handout materials.
